1. Type of Programme

• Short Learning Programme (SLP)

Short programmes upgrade skills and knowledge to ensure success in a chosen field of learning, but are not credit bearing.

2. Description

The Short Programme in Make-up will introduce the student to the practice of day, evening and special occasion make-up. The student will learn how to maintain good practice and hygiene in all procedures, and how to perform and use different techniques in order to achieve a professional make-up application.

The purpose of the Short Programme is to equip the student to work in the Health and Skincare industry/Salon/Spa or at a Cosmetic make-up brand as a professional basic Make-up artist. It is an ideal short programme to add on for manual facial therapists, nail technicians, eyelash extension technicians and hairdressers as it will upgrade the skill of an individual.

3. Admission requirements

- Knowledge, comprehension and application of English language and Mathematical literacy at Grade 12 or equivalent.
- Admission may be subject to an interview with an academic staff member.

4. Duration

The programme duration consists out of 60 total hours, including practical, theory and case studies. Theory is completed in a self-study manner, while practical training is face to face and case studies are completed in a private capacity. Case studies need to be completed within 4 months from course completion. Dermatech tuition is scheduled at specific times of the year. Programmes are offered during week days. After successful completion of the assessment, certification will take place.

5. Textbooks and study material

All prescribed material and kit is included. A list of student material and textbooks if necessary will be provided by Dermatech campus academic department.
