The purpose of the Short Programme is to equip the student to work in the Health and Skincare industry as a professional Permanent Make-up Technician. It will upgrade the skill of an individual that works in a Salon or Spa environment. This is a very unique proficiency that is still growing and very in demand.

3. Admission requirements

- Knowledge, comprehension and application of English language and Mathematical literacy at Grade 12 or equivalent.
- Admission may be subject to an interview with an academic staff member.

4. Duration

The programme duration is 40 total hours, including practical, theory and case studies. Theory is completed in a self-study manner, while practical training is face to face and case studies are completed in a private capacity.
